**Summary Annual Report for
STEELWORKERS HEALTH AND WELFARE FUND**

This is a summary of the annual report for STEELWORKERS HEALTH AND WELFARE FUND, EIN 23-1317409, Plan Number 501, for the year January 1, 2007 to December 31, 2007. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The Plan has contracts with Highmark Blue Cross Blue Shield, Blue Cross Blue Shield of Western New York, Anthem Blue Cross Blue Shield, Empire HealthChoice HMO, and United Concordia Insurance Co. to pay medical and dental claims incurred by eligible participants under the terms of the plan, and with Fort Dearborn Life Insurance Company to pay life, AD & D, sickness and accident and long term disability benefits incurred by eligible participants under the terms of the Plan.

The total premiums paid for the plan year were \$ 374,659,141.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$ 35,573,852 as of December 31, 2007, compared to \$ 29,387,883 as of December 31, 2006. During the plan year the plan experienced a change in its net assets of \$ 6,185,969. This change included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$ 382,382,209 which included employer contributions of \$ 372,824,214, participant contributions of \$ 4,535,318, gain/loss of \$ (6,367) from the sale of assets, and earnings from investments of \$ 4,072,539 and other income of \$ 956,505.

Total plan expenses were \$ 376,196,240. These expenses included \$ 1,537,099 in administrative expenses and \$ 374,659,141 in benefits paid to or on behalf of participants and beneficiaries.
