### Lima Energy to Supply 22,000 b/d of Synthetic Crude Oil to Husky's Lima Refinery

Lima Energy Company, a subsidiary of USA Synthetic Fuel Corporation, has signed a contract to supply up to 80 million barrels of oil equivalent of Ultra Clean Synthetic Crude (UCSC) to Husky Energy's Lima Refinery over 10 years. The Lima Energy Project is being designed to convert solid hydrocarbon (coal, petroleum coke, and renewables) feedstock into low cost Global 1<sup>TM</sup> UCSC. The UCSC will be manufactured next door to the Lima Refinery, eliminating the significant supply costs and logistics of transporting oil. The contract calls for volumes of up to 22,000 b/d starting with an initial production volume of about 7,000 b/d.
